The Astwell Benefice

Financial Statement Report for the year ending December 2022

During 2022 the Benefice paid £62,714 to the diocese as our Parish Share. This is 90% of our full share. This is the first time we have been able to contribute over £60,000. Most parishes contributed more than they had in 2021.

Other costs were paid in full funded by £8,244 from Wedding & Funeral fees, £6,270 from fundraising, £982 from the Rogation and £221 from donations.

The balance in the books at the end of the year was £6,700, of this \pounds 447 is ring fenced for the choir.

We have agreed a Benefice budget of £10,845. This covers secretarial pay, organist, and mission and ministry costs and includes £3,475 towards the share.

Helmdon and Radstone's Financial Statement Report for the year ending December 2022

The closing balance at the end of 2022 was £9,643. Of this £1,583 is due to be paid to two charities from a memorial service held in December and to the Children's Society. Restricted funds were £4,762 including churchyard income, donations for the Organ and Children's Church fund (currently standing at £3,162) and a Diocesan grant received during the year towards energy costs.

During 2022 Helmdon paid the sum of £21,500 and Radstone £500 towards the Diocesan Share. Another £150 was paid directly to the Benefice and allocated to us. In total £22,150 constituted 94% of Helmdon and Radstone's Share allocation, a substantial increase on the previous year.

During the year the final payments were made for the work to remove bats from Radstone church, funded through Bats in Churches. There were collections from four services. At the year-end a total £610 was being held in Helmdon's accounts. This, together with £145 in Radstone's bank accounts comprises Radstone's current account balance in the statement of assets and liabilities.

Donations received included those from the Friends of St Mary Magdalen which contributed generously for the repair of the roof. Regular giving was £15,590, with collections and wall box contributing a further £4,920. Over £3,400 was raised during the year through a variety of activities including a Race Night and Christmas Fair.

£550 was donated to charity, primarily for British Legion from collections made on Remembrance Sunday and to Farm Africa from a memorial service for Douglas Hadfield.

LOIS WEEDON FINANCIAL REPORT FOR THE YEAR ENDING DECEMBER 2022

General (Unrestricted) Account

The closing balance on the Operating Account as at the 31st December 2022 was £2,559.43, a significant improvement from our starting balance of £1,366.32 on the 1st January 2022.

We received £3,281.00 in Regular Giving (up £498 on the previous year), £2,671.75 from service collections, wall box (up £175 on the previous year) and £1,689.25 in Donations and Floodlight Sponsorship (down £394 on the previous year)

Fund raising activities significantly increased year on year due to the relaxing of Covid rules and we raised £1,965.15 (up £1,640). Events held included a Tea Party, a Cheese & Wine Evening, a Harvest Supper Evening, a Christmas Market stall and Carol Singing.

Parish Share was constrained at £6,101.60, which is down on our contribution in 2021, in order to manage our cash-flow and day to day running costs for the church.

Utility costs (electricity) are up £205.82 on the previous year after receiving an overall refund of £456.91 plus £30 compensation from SSE following investigation of previous charges. Costs remain high because of the international energy crisis but we do benefit from the UK Government Business Energy Scheme (at least until the end of March 2023) and we received a £755 energy grant from the Diocese. We continue to investigate consumption, which remains high.

Restoration (Restricted) Account

The closing balance on the Restoration Account as at the 31st December 2022 was £8,202.79, up £654.07 from the start of the year. Minimal activity was recorded.

A donation of £1,266.35 was received from community fund raising as a result of the Cake & Plant Sale held on 7th May 2022 plus further single Donation Of £300 was made by a parishioner.

An invoice of £2,059.20 was settled to Stimpson Walton Bond for architectural services associated with the ongoing Servery and WC project.

Other Matters

In November 2022, significant cracks had appeared in the West wall of the Chancel causing damage to the window and surrounding area. This is now subject to ongoing investigation and will undoubtedly attract significant costs to repair.

Certain essential works were immediately undertaken to secure the area and prevent any further damage, the cost for which are £1, 859.31 to be settled in early 2023.

The Churchwarden has called together the necessary parties and we now await quotations for the repairs. This will necessitate fundraising activities as well as the application for available grants.

DECEMBER 2022

INCOME

It has been a sorrowful year in Syresham losing parishioners due to either sadly dying or leaving the village. This reflects in the Regular Giving figure. However collections are higher than last year due the fall in Covid Cases life style and accepting the situation. The PGS scheme has settled down with a regular income of over £600. However there has been a loss in Gift Aid, again due to the losses we have sustained via Regular Giving.

We have been fortunate in receiving a substantial amount from Trust Funds via the Friends of St. James for fabric costs and Cemetery work when needed. A Silver Birch Tree has been planted in the Church Yard marking the Queen's Jubilee. This was paid for by the Friends along with a new ramp and updated noticeboard.

We continue to have a small flow of monies via Easy Funding. We had very successful fundraising this year to the value of £2,600.

We have received donations to the Church from the families in respect of 3 funerals.

EXPENDITURE

A total of £13,100 paid to the Benefice re parish Share, a fraction more than last year.

Utilities are marginally higher due to obvious increases nationally but the amount of £755 from the Diocese was very welcome helping with costs incurred. Utilities are expected to increase in 2023

Charitable donations were made to the amount of £320, from Harvest and Christingle Services

Plans are going ahead for a new Sound System.

Income

2. Benefice Committee Reports for year ending December 2022

2.1 Benefice Finance Committee Report 2022

The Finance Committee met in June, November and January. Agreements on the APCM contents were done by email during March. We welcomed Clive Johnson to the committee representing Lois Weedon.

During meetings we shared the financial positions, highs and lows of each parish, discussing fundraising, regular giving, collections and extraordinary expenses that face us all. We reported to the BPCC at each of their meetings.

We ensured that all the benefice and parish accounts were prepared for examination in January. All quarterly returns and parish share contributions were submitted to the diocese in a timely fashion. All finance parish returns for 2021 were completed.

We were pleased to be able to pay 90% of our parish share this year and are very grateful for the fundraising committee for their contribution to the Benefice payments.

We set the Benefice Budget for 2023 but believe that Parish budgets should be set by the church councils, apart from parish share contributions which are unchanged this year as the benefice will take on the extra £1 we need to find.

2.2 Benefice Worship Committee Report 2022

I am writing this report as we near the end of Lent and look forward to celebrating Easter. During this period when we forego certain things to allow us to focus on God, it is somewhat ironic that yet again we are having to do without a Rector!

Under Rev Diane's leadership in 2022, the service pattern was reviewed based on feedback from the congregations around the benefice. Perhaps not surprisingly, the feedback was largely supportive of the existing pattern and very little was changed in terms of the nature or frequency of the service offering throughout the benefice.

Since the review, Rev Diane retired on 30th November and Wiggy Smith retired as a Reader in October. Both occasions were marked by well attended services and we were able to reflect our gratitude to both with appropriate gifts.

Inevitably, the loss of our Rector and the reduction in Wiggy's capacity has placed a great deal of pressure on the service pattern. Much of this falls on our secretary, Sarah Rudkin, who does a sterling job in contacting and persuading retired priests to cover services. In spite of these challenges, the benefice succeeded in delivering a very full and varied programme of worship and praise over the Christmas period and our plans for Easter suggest, again, a very full programme of worship and refection.

There are many people across the benefice who play a crucial role in helping to maintain the extensive pattern of worship who deserve our thanks. There are those who step forward to lead worship; Alice Palmer, Michael Streten, Bill Elkington, the team in Wappenham and Wiggy (despite "retiring"). These are, if you like, the obvious ones. But I should also like to thank everyone who contributes to the life of the benefice and parishes. Whether you clean, organise rotas, arrange flowers, make coffee, read lessons, lead prayers, sort out music, play the organ, ring the bells or whatever...thank you! Without you our services simply could not happen.

The challenges faced by the benefice are much the same as those faced by the wider Church of England. Whilst there are some encouraging signs (the children's church activity in Helmdon is just one example), there is a need to challenge ourselves on how we engage with the rural communities we serve, whilst continuing to support our existing congregations.

However, until such time as we have a Rector, we are managing well and continue to be joyful, keep the faith and carry on!

The Astwell Benefice Quiz Challenge was a great success – hosted by the individual parishes with sponsors where possible. The Helmdon Team were once again the victors, many congratulations. These five events raised £2396

The Jubilee Garden Party, kindly hosted by Lady Sue Greenaway at Lois Weedon House, was fairly well attended (the weather wasn't the best). With a mixture of stallholders, music, delicious teas and a tour of the gardens, visitors had a very enjoyable afternoon and we raised over £900. However, the Grand Draw which was announced on that afternoon (having sold tickets for weeks before the event), raised just over £2,300.

The next event was the Barn Dance, held in early July. Tickets were slow to sell and the cost of the band made it hard to make a profit. However, it was an excellent evening and we cannot thank our 'chefs' enough for volunteering to cook all the food on three different barbeques. The profit from this event was £635.

So – by the end of the calendar year we had raised £6270.76 which we were delighted to put towards Benefice expenses – but we all had a good time too!

2023 is running along similar lines as 2022, the Quiz Nights are coming to a close, the Barn Dance is organised and being advertised (17th June) and we have some exciting ideas for the Autumn.

We have said farewell and thank you to Malcolm Orr-Ewing, Geoff Hillman and, of course, Diane - all having moved out of the area. We welcomed Andrew North to the Committee towards the end of 2022 and he is already a valued member of the team.

Thanks go to all the committee mentioned at the top of this report and also to our sponsors and helpers throughout the year. Thanks also to Alice for keeping me on the straight and narrow with the accounts!

2.6 Deanery Synod Report 2022

The deanery synod has 4 meetings a year, one of the meetings is a full worship service. The usual format is a short 10-minute service followed by a 30 minute talk and 10 minutes or more for questions. This is followed by tea, coffee and cake where you can mingle and talk to other churches.

At the last meeting at Kings Sutton Church where Archdeacon Richard was talking about "The challenges and opportunities of the church today". This was a very interesting talk for us based on rural parishes. 80% of the diocese consists of rural parishes when 90% of trainee priests come from an urban parish. Richard outlined the huge advantages rural parishes have over urban parishes.

Everyone knows the vicar.

Everyone relates to the church even if they do not go it.

More parishes are looking towards a united benefice, (an example with separate PCC's parish A agreed something with the vicar, Parish B modified it, Parish C revised it. It then had to go back to parish A before parish D and E had a go). Astwell was held up as an example of a united benefice. Several churches over tea and cake asked me how it works.

Rural parishes are more open to mission as the schools have a link to the church without being church schools. In rural locations Chapels, Baptist and Methodist churches are closed or closing giving scope for mission.

Parish share is an issue and Daventry was used as an example 30,000 people one Anglican church, Richard quoted two benefices with 30,000 people one had 151 churches the other 155 churches. This is being looked at by the diocese. No churches can be closed only by the local PCC and incumbent who jointly own the church. The diocese prefers changing the church to a Chapel at Ease joined to a larger parish church. If a benefice is not actively trying to meet their share the only diocesan option is a house for duty or half time priest. This usually means the benefice is dying.

2.7 Benefice Hope Centre Run Report, 2022

As Malcolm Orr-Ewing, the previous co-ordinator, now lives outside the Benefice he has passed administration of the Hope Centre weekly run to me. However, he continues to be a driver. On the current rota we have 14 drivers including a recent recruit, Russ Woolley from Syresham. Collections are on Tuesdays at around 12 noon from Faith Dimensions in Wolverton, with deliveries now to a slightly altered Northampton town centre address as the Hope Centre kitchen has moved to a site near to its Oasis House base. However, there have been occasions when drivers have arrived at the new location only to be asked to deliver to the old. Representations have been made to the Hope Centre about the need for clarity and consistency.

Polystyrene cool boxes (for transporting frozen foods) are used by drivers, but seem to deteriorate quite quickly. A convenient and easily accessible location to store the boxes would be very helpful now that Malcolm's outbuildings are no longer available.

We are grateful to all drivers for giving up their time and being prepared to do the run up to four times a year at their own cost.

We are grateful for her support of the Choir's activities, and for singing Alto with us.

It was a pleasure to be able to sing at Christmas carol services after a three-year break owing to the Pandemic. This year, we sang pieces at Helmdon, Whitfield and Lois Weedon, all of which went down well, with very good attendances.

As always, we would very much welcome new members, and look forward to continuing to enhance the musical life of the churches in our Benefice.

The year got off to a slow start with us again joining with the village festival. That was disappointing as the main area up on the school playing field was fenced off and our takings greatly reduced. We will hold our own Church Fete this year.

Our electricity agreement ran out at the end of the year, the company that looks after this (free) has changed our supplier for a cheaper deal. We could get better deals if other churches joined with us as they would have a better negotiating position.

We had a water leak through the roof of the lady chapel and after experiments we extended the lead flashing 2 meters under the clerestory window, which has stopped the leak. This cost was covered by the friends. The DAC came to view the church with regards to re-ordering as we need to create space for our growing children's church, although at the time of writing we still await the Committee agreement in principle to our outline ideas. We have decided to carry on with the planning despite being in interregnum and to take advantage of our architects visit to inspect the building and fabric during the Quinquennial review this summer.

Our friends had a very enjoyable classical music evening in September (see Friends of Helmdon Church section below). We thank our Friends for all they do towards the church upkeep and repair and hence our village.

We had another musical evening in the church with a Greek-themed meal and the film Mama Mia shown. This was a great success, and we had a request for another one to be put on.

We held a very successful race night in the autumn followed by a Christmas Fair that boosted our fund raising for the year enabling us to pay a record parish share. Hopefully this year we can excel again.

The new year started with a successful pancake day and planning for 2023-24. Helmdon Reading Room has replaced their chairs and donated 21 of the old chairs to the church. This has ensured that we can now seat 120 people for events.

It was a blow when Rev. Diane retired but all the benefice responded with lay people doing more services and our reader giving communion by extension.

There was a delay in finalising the Benefice Profile in readiness for the Vacancy to be advertised. This was compounded by the diocese omitting the dates for interview etc. Radstone church is unrecognisable now the work due to the bats is finished. A BBC Songs of Praise team came to film an evening with bats that went out in October and those who went enjoyed themselves. Our thanks to Penny Bonner for all the work she does for Radstone church which with the 5th Sunday services is viable. We are still waiting to see the extent of HS2 on Radstone as work seems to have moved further north.

Churchwarden Report to the Astwell Benefice

1. Parish Status

2022 was a year of cautious recovery from the darker days of the Pandemic.

We all face continued pressure on fundraising and we continue to rely upon our loyal supporter who as we all know, are not getting any younger and indeed may be fewer. Despite these challenges this last year has, if anything, consolidated our position in Lois Weedon. There seems to be an acceptance within our Benefice community that we are all trying our very best and the Diocese have at least given us the impression that they are sympathetic to our plight.

Our revenue is certainly better than pandemic days. Perusal of our accounts show an improvement in regular revenue from £9,100 to £12,800. Remarkably, our congregation and supporters have kept their contributions coming. Our target Parish and Benefice Share is still beyond our capability but everyone is in the same boat.

We have sadly lost our Rector and once again we will fall back on our own resources. Diane's tenure coincided with the tremendous challenge of the COVID pandemic. The toll on her health was unbearable and we must be grateful for her willingness to give all she could for our benefit. We in Lois Weedon have the benefit of the Rector's accommodation although your Churchwarden doesn't need another house to look after. I hope that it's improved condition will be a significant asset in attracting a new incumbent as soon as possible.

During Covid we managed to hold 27 out of scheduled 36 services. In the last year we had 33 Sunday services. Of those services there were 24 'standard' services in 2021 and 25 in 2022. The late afternoon, early evening Evensong were poorest attended. Our overall 'standard' morning service attendance was 12.95 in 2022 and 14.58 in 2021. Whichever way you look at it we are not increasing.

2. Fabric

Having secured the Church from water ingress we were then thwarted by drought. God moves in mysterious ways as does our Church building. Late in 2022 a different set of cracks appeared caused by the prolonged period of high temperatures and lack of moisture in our subsoil. The infamous clay resumed it's shrinking and caused cracks to appear around the east window. As a result the keystone at the top of the window no longer needed to perform its' function and dislodged itself threatening to descend upon any passing parishioner. We are dealing with it.

The Servery and Toilet is ongoing but we need to attend to the window before we can contemplate redecoration or amenities.

3. Mission

The Church exists to serve its people by guiding and helping us all to lead a loving and fulfilled life. Unfortunately, there is no handy concise manual. So we do the best we can. Clearly, for the Church to survive it must appeal to those who could potentially help to support and continue its mission. I am convinced that my own somewhat reluctant willingness eventually to get involved started when I was a child. Regardless of whether you approve or disapprove of the role of Religious Organisations I see the story of Jesus Christ as the best children's story of all time. You couldn't make it up. And don't think it's just me, think of all the stories out there, whether in books, film or folklore. Can you think of any that doesn't have at its core the preference for good over evil.

Our Benefice and our own parish community have that in mind in all we try to do. We welcome the opportunity to help those who are in trouble. Our Pastoral care group under the guidance of Wiggy are here to help but we need to know who is in need.

4. Fundraising

Our fundraising activities did perk up but are probably not at full throttle. The highlights were the Benefice Garden Party and the Barn Dance, with our own Caroline R's Tea party and Jill and Donna's Plant and Produce sale. Easyfundraising has given us a modest but welcome income but we recognise that people need a better understanding and 'coaching' on how to use it.

We will be holding regular coffee mornings again but with greater ambition. We hope to spread our net wider and see if we can attract people from outside our more parochial group. There are several of our supporters who may not be regular churchgoers but who have sympathy for our endeavours.

The popular Quiz is reaching its latest conclusive round having proved very popular and financially successful last year. Also the Benefice Barn Dance will once again take place at Manor Farm in June. Last year proved popular but we hope to encourage even more to join in especially in the lighter warmer nights.

The fundraisers have been a major contributor to the running costs of the Benefice relieving the pressure in the parishes.

5. Church Council

Our Church Council is now able to meet in more convivial and warmer surroundings. Roughly once a month we meet to discuss our Church matters. Unfortunately Geoff Hillman has escaped to a different part of the country but I am delighted that Sue Greenaway has agreed to join us. Iris Gregory is also joining us which I take as a compliment that she would agree to be a part of an enterprise involving me.

1. Worship. We have enjoyed being back to full worship especially over Christmas. Messy Church met three times over the year; five families have expressed interest but we tend to get two or three on the day. Christingle is our most popular service for those outside the church, but our Joint Jubilee and Remembrance services were well attended too.

Of our regular services our two communions attract folk from other parishes, thus boosting attendance figures. Our other services are Morning Worship and Praise and Prayer. In the latter we often learn about the lives of folk or share ideas from the congregation. This year we have included Desmond Tutu, Prayer, Timothy, "About Alice" and Brenda's thoughts on the Passion Flower.

We have been greatly saddened to lose members of the congregation and close friends and relatives, marking seven funerals in church and another three deaths of loved ones. We loved hosting one wedding and four baptisms, and were excited to welcome some new members to our congregation.

2. SCC Syresham Church Council met in May, August, October and February. We have been planning church fundraising; supporting the school in the form of prayers, assemblies and cake; discussing improvement and maintenance works to our buildings and churchyard; monitoring our finances with the help of our excellent treasurer Brenda; and discussing special worship opportunities such as the Jubilee service, Harvest and Remembrance.

Hammond Fund manager) Margaret Miller (Friends rep) David Wright (Hammond fund rep) **3. Building works**. Our new sound system has been installed and is a great improvement. We continue to work through our 158 Quinquennial tasks with the Churchyard Working party taking on a list of tasks, and our new indoor maintenance team tackling the cleaning of the clear windows. We are struggling to get a suitable quote for the work needed on the steeple and are awaiting the arrival of the builder who will carry out some of the other works around the church. We have also organized the pruning of yew trees in the extension churchyard and the mending of steps.

4. Church Helpers

We are forever grateful to the church members who help us to run the church by cleaning, decorating with flowers, reading in services, leading intercessions, serving coffee, leading services, playing the organ, ringing bells, lighting candles, setting up for services and welcoming folk coming to worship – it wouldn't work without you.

5. Churchyard Working Party

A core team, which has been working for years on the churchyard, met in January to consider works required by our Quinquennial inspection. We were delighted to welcome new helpers to our first Saturday Morning working session to help tackle some of these tasks. We also thank our mowers who keep the grass around the church under control.

6. Friends of St James The committee has a new lease of life, welcoming new members. Their fundraising is principally done through the 200 club. The committee organized a very successful autumn walk and soup lunch, followed by a Christmas party and then a pancake lunch in school. They have supported the church by helping to pay for the media player and remote control for the new sound system; paying for the tree that we have planted as part of the late Queen's Canopy; updating the church noticeboard and paying for the new ramp to help with accessibility in the church.

7.Fundraising We held a very happy and successful Blackberry Fair at the Priory and St Nicholas Fair in Church meaning we raised £2600 this year. We plan a **NOTE-ABILITY concert July 1st**, a **FETE September 2nd** and our **Christmas Fair December 2nd**.

8. Trusts The Madge and Maud Payne trusts have continued to support us with our maintenance work. We welcome Brian Miller as our new Trust Chair. The Hammond Trust enables us to deliver plants to folk at Christmas time and buy bibles and books for the school children. We also allocated £500 to support the chapel in creating a warm space but the take up has been small so we have not needed it so far.

9. The Bell Tower It is wonderful to have a clean Bell Tower for ringing before major services with bell-ringers practising regularly. Many thanks to Andrew North for leading the tower - also for doing a lot of cleaning with his trusty helpers. There are now four bell ringers in Syresham and others from the local area come and support where needed.

10. Our thanks: To Revd. Diane for the work she did with us before her retirement and to Paul Stothard, Rev John Roberts and Rev Will Adams for leading our services.

1. Churchwardens' Report

Our thanks are expressed to all members of the Wappenham Church Council during its first year of operation. Chaired by Edwin King, these included Sheena Warren, Peter Oliver, Anthony Tucker, Philip Thompson, Jane Mordue, Angus Wade, Michael Bath, Di Watts and Barbara Gundle.

The parish's Church Councils would continue to hold bank accounts and be responsible for fundraising and expenditure on fabric.

1.1 Building and repairs

Following the Quinquennial review in 2021, financial provision was planned to cover costs. Initial works are being planned and quotations sought.

In May 2022, we were pleased to welcome Archdeacon Richard who led the service of thanksgiving for the Church's newly repaired steps and new pew cushions.

Thanks are expressed to all those who maintained the church yard and cemetery. Robert Tomkinson kindly continued to mow the grass in the churchyard extension. Our gratitude also to all those who give their time to do the flower arrangements, clean the church, and fulfil numerous other jobs which ensure the church continues to have an attractive aspect.

1.2 Fabric

There have been no additions or removals from the Church other than the kind provision by a parishioner of pew seat cushions.

The Church continues to house equipment providing high speed broadband for the village and surrounding area. During the year a piece of masonry fell from the tower damaging the boiler house roof. The crenelation has been reinforced and insurance is awaited to deal with the repairs to the boiler house roof. A bell rope was replaced in the bell tower.

1.3 Worship and attendance

The Church is open daily for services or private prayer and reflection. A regular pattern of services has been maintained including Holy Communion, Morning Prayer, Village Prayer and Praise and Breakfast Church. Attendance remains steady by the usual congregation with broader community support at Christmas and Easter time.

We were sad to bid farewell to Revd Diane in September and thanked her for her ministry. We thank the other members of the team for their ministry and pastoral support. The pastoral reporting system was considered and strengthened to ensure better communication between the village and ministers.

4.1 Expenditure

4.2 Income:

5.2 The Friends of St Mary the Virgin Wappenham, 2021

The Friends is a registered charity (number 1116889) established as a trust to enable fund raising and fund management for the maintenance, repair and restoration of the fabric, grounds, graves, graveyard boundary walls and gates of the Grade II* Church of St Mary the Virgin, Wappenham.

The Friends trustees are: Jane Mordue (Chair), Anthony Tucker (Secretary), Alastair Judge (Treasurer), Sheena Warren (Churchwarden), Edwin King (Churchwarden) and Di Watts.

5.3 Friends' Treasurer's Report

The Friends' funds stand at £5,361 (2021 £4,420.99) of which £750 is earmarked for the WC.

Income in 2022 was £1,405 (2021 £1,260 and outgoings were £30 - bank fees - (2021 £0). There is also outstanding Gift Aid awaited.

In recent years as the Church had undertaken its own fund-raising events, the Friends has focussed on supporting these and receiving regular donations. In 2022 the share of 'profits' from the annual Wappenham Beer and Music Festival went directly to the Church Council but has been ring fenced for the Church Fabric Fund. There was one small fundraising activity during the year – open gardens plant sales.

5.4 Works and Faculties

1. Whitfield Church Council Representative(s) Report

Whitfield Church Council met four times during the year.

<u>Church Council Members</u> - Claire Bonner -Chair; Sue Timmis, Gloria Gardner; Nick Goodwin; Carol Rhodes; Jane Rymell; Bo Wallace. Treasurer – Brenda Faragher.

Our biggest challenge is financial, although this goes hand in hand with our small congregations. We are barely meeting our overheads. Although we were pleased to be able to contribute 77% of our Parish Share contribution to the Benefice.

We were honoured to host the Benefice Memorial Service following the death of HM Queen Elizabeth II in September. The Bells were rung at this time of mourning, and for the accession of King Charles III; all parishioners were invited to take part by tolling a bell to mark this historic occasion.

We have not been able to hold the village fete since before Covid, due to lack of manpower to run stalls and organise a large event such as this. Instead, we aim to hold smaller events such as a Drive Sale, themed supper evenings, coffee mornings and breakfasts.
